We are halfway home! Lawmakers hit the highway Thursday afternoon after having completed the 20th of the allotted 40 legislative days. It's a good reminder that just because half of the days are complete, the work of the session is far from halfway done – quite the contrary. The pace of the last 20 days will far surpass that of the first 20. Lawmakers will return Tuesday to get the ball rolling once again...so stay alert.

Action on several key bills is expected next week, including GATE and truck weights. Here's an update on bills of interest:

AG TAX EXEMPTION CHANGES (GATE CARDS)



Since <u>HB 911</u> was introduced late last week, we have had several meetings around the Capitol with key leaders in this

debate. Meetings with the sponsor, Rep. Geoff
Duncan, House Ways & Means Committee Chairman
Jay Powell, House Ag Chairman Tom McCall, Rep.
Sam Watson and Agriculture Commissioner Gary
Black have all been very helpful. Through these
discussions, we expect several adjustments to the bill to be
made. In addition, we have growing support for moving
the annual card to a multi-year card that would be
good for our industry. Increasing the \$2,500 minimum in
annual sales up to \$10,000 is an issue we continue to
discuss and keeping the program under the control of the
Georgia Department of Agriculture is very
important. We're also expressing concerns about potential
GATE sales requirements that may be put on retailers.

TRUCK WEIGHT LIMIT INCREASE





The truck weight increase bill is set to start moving as early as Tuesday next week now that the benefits and concerns have started to settle. A revised version of **HB 411** will be provided to the House Transportation Committee by **Rep.**Sam Watson and the next phase of lobbyist input will begin. Moving the overall truck weight limit from 84,000

lbs up to 88,000 lbs is priority for this effort – but it will be an uphill battle. We commend **Rep. Chad Nimmer** for his fact-finding work over the past year. The input and data stemming from his good work will be key to shaping the next steps for this debate. Stay tuned as this debate picks up speed...

TAX FILING COMPLIANCE FIX:



Rep. David Knight's HB 742 cleared the Senate on Wednesday and has now landed on the desk of Governor Deal for signature. We appreciate Senate Finance Committee Chairman Senator Judson Hill for leading the bill through the Senate. Once signed by Governor Deal, we'll have the necessary state language to take advantage of the Section 179 expense deductions passed by Congress in late December. This law provides for up to \$500,000 for those in the agriculture heavy equipment industries and we are very pleased with the expedited handling of this legislation to help with tax filings. Rep. Knight for his leadership in tackling this issue so early in the session.

BUDGET

This week, Governor Deal announced Georgia's tax collections for January 2016 were up 6.4% over January 2015...a great sign of continued growth. As the state collections improve, so does the budgeting process for those dollars. The FY 2016 Amended Budget passed the Senate on Wednesday, setting the stage to have it sent to the desk of the Governor soon. There is still work to do, but you can click here to see the latest tracking document. The FY 2017 Big Budget began moving through the numerous House subcommittees this week. It includes funds for the Georgia Dept of Agriculture to further improve the numerous state run farmers markets across Georgia. Bond funds that will assist the Georgia Forestry Commission, the FFA/FCCLA Center, and the Soil & Water Conservation Commission, among others are also included. There are numerous long overdue state wage adjustments for teachers and state workers. We'll continue monitoring the long and thorough budget process as it builds momentum.

PROPOSED UAV COMMISSION

With UAV use on the rise, there has been more interest from legislators and the public on how to manage and regulate their use. **Senator Judson Hill**'s **SB 325** seeks preempt local regulations with a statewide approach, which we support. It also outlines the development of a five-year "**Georgia Unmanned Aircraft**

Commission" to better evaluate the various benefits of drone use for the state. Public safety, job creation and positive economic impact are among those topics. Unfortunately the bill does not include agriculture as a part of this potential commission - we are working to fix that.

STREAM BUFFER LAND GRAB

A new battle over stream buffers has surfaced in the form of HB 966. This bill was crafted by a host of environmental groups that aspire to make your land become their land. By adding a definition of "ordinary high water mark," they want to move the required 25ft state buffer on most streams from the normal level of water flow to the highest possible level, which is **eerily identical to wording used in the federal Waters of the US (WOTUS) regulations** that we and other ag groups vigorously opposed. This action would grow the buffer width and take land out of production or use, in addition to building the case for litigation. We'll be watching this one closely. It has been assigned to the House Natural Resources Committee.
